The Cabinet Secretary reviewed various issues pertaining to the Government e-Marketplace (GeM) on 11-09-2017. With procurement of 163 crores through GeM, the MHRD is second only to MHA which has made 196 crores worth of procurements. The single largest agency is the Kendriya Vidyalaya Sangathan. The following decisions were taken at the meeting:

- (i) All Departments and Autonomous Bodies should produre only through GeM.
- (ii) No orders should be placed without full availability of budget. All autonomous bodies should therefore be on PFMS or create a separate Dedicated Pool Account to pay for the procurements.
- (iii) All payments should be made online
- (iv) All pending payments should be cleared immediately.
- (v) All Departments should encourage onboarding of regional level vendors.
- Cabinet Secretary further stated that the Secretary of each Department will be responsible for the implementation of GeM and that all Secretaries should take a meeting on all issues pertaining to GeM, the FA should be invited to this meeting.
- 3 As per the directions of Secretary(SE&L), it is requested to kindly take appropriate action in accordance with the aforementioned decisions for strict compliance.
