Subject: Annual Performance Assessment Report (APAR) — Inclusion of columns for safeguarding the interest of officers/persons belonging to Scheduled Caste and/or Scheduled Tribe - reg.

The undersigned is directed to invite a reference to MHA, Department of Personnel and Administrative Reforms OM No. 21011/3/79-Estt(A) dated 25.07.1979 and OM No. 21011/2/83-Estt.(A) dated 08.04.1983 providing for columns in Part I, Part III and Part IV of the Annual Confidential Report (ACR) form to safeguard the interests of officers belonging to Schedules Castes and/or Scheduled Tribes (copies enclosed for reference).

- 2. The National Commission for Scheduled Tribes in its meeting with the Secretary and other officers of DoPT has directed that the existing instructions need to be reiterated and the report needs to specifically address the concern of the Commission regarding attitude of the officers reported upon towards the members of Scheduled Tribes.
- 3. All Ministries/Departments and Cadre Controlling Authorities are requested to ensure that the instructions contained therein are followed meticulously in letter and spirit.

OFFICE MEMORANDUM

Subject:

Instructions for the purchase of laptops/notebooks and similar devices for eligible officers – revised guidelines.

In supersession to this Ministry's Office Memorandum bearing No. 08(64)/2017-E.II(A) dated 27th September 2016, regarding purchase of Note Book/Lap-Top computers by Ministries/Departments & delegation of powers thereof, it has been decided that lap-top; tablet; notepad; ultrabook; notebook, net-book or devices of similar categories may be issued to officers of the rank of Deputy Secretary and above for discharge of official work. These powers shall continue to be exercised in consultation with the Financial Adviser by the Secretary of the Ministry/ Department or any other authority who are specifically delegated these powers by this Ministry from time to time, duly taking into consideration the functional requirements and budgetary provisions.

- This would, however, be subject to the following conditions:
 - (i) Cost of device: The Cost of device including Standard software* shall not exceed Rs. 80,000/-.

Standard Software: Any software (Operating System, Antivirus software or MS-Office etc.) that is essential for the running of device towards discharge of official functions/duties.

- (ii) Purchase Procedures: As prescribed under GFRs/CVC guidelines may be followed.
- (iii) Safety, Security & Maintenance of Device: The officer, who is given the device, shall be personally responsible for its safety and security as well as security of data/information, though the device shall continue to remain Government property. The officer concerned will be at liberty to get the device insured at his personal cost.

(iv) Retention/Replacement of device:

- a) No new device may be sanctioned to an officer, who has already been allotted a device, in a Ministry /Department, up to five years. Any further issue of laptop in case of loss/damage beyond repairs within the prescribed period, should be considered only after the cost is recovered from the officer based on the book value after deducting the depreciation.
- b) For the purpose of calculation of the book value, a depreciation of 25% per year, on straight line method, be adopted.
- c) Post the completion of five years of usage, the officer shall retain the issued device.

(v) Conditions at the time of transfer, Superannuation etc.:

a) In case where, at the time of purchase of device if the residual service of the officer is less than 5 years or in case the officer is transferred/deputed to State Govt. but with residual service of less than 5 years or the officer leaves the Government Service within 5 years of purchase of such device, the officer concerned will have the option of retaining the device by paying the amount after deducting the depreciation.

b) Upon transfer/deputation of the officer to other Ministry/ Department/Attached/Subordinate offices of the Government of India or to the State Government in case of Officers of the All India Services, the officer will have the option of retaining the existing device and in case of such retention, this fact should be specifically mentioned in the Last Pay Certificate (LPC).

Instructions for Ministries/Departments:

- (i) For the officials who are currently holding laptops, notebooks or similar devices in accordance with the provisions of O.M. dt. 27/09/2016, the terms & conditions for retention/disposal of the device shall continue to be governed under the existing instructions of the said O.M.
- (ii) The applicability of the provisions of this order to the officers of Armed Forces/Para-Military Forces, officers of MoD & other similar establishments would be subject to restrictions imposed by the concerned departments/organizations duly taking into consideration the security of information. In all such cases the security of the information shall be the responsibility of the concerned department.

Sub:- Amendment of instructions regarding dearness relief to re-employed pensaioners consequent on revision of ignorable part of pension for fixation of pay in the re-employment post-reg

The undersigned is directed to refer to subject cited above and to say that the grant of dearness relief to re-employed pensioners/family pensioners is presently regulated in accordance with the instructions contained in this Department's OM No. 45/73/97-P&PW(G) dated 02.07.1999 and subsequently amended vide this Department's dated 38/88/2008-P&PW(G) dated 09.07.2009

- 2. DoPT, vide their OM No.3/3/2016-Estt.(Pay II) dated 01.05.2017 have issued instructions for revision of ignorable amount of pension from Rs. 4000/- to Rs. 15000/- (Rupees Fifteen Thousand) for the purpose of fixation of pay in the re-employment post. Accordingly, the amount of Rs. 4000/- appearing in this Department's OM dated 09.07.2009 is revised as Rs. 15000/-(Rupees Fifteen Thousand). The other conditions for grant of dearness relief in OM dated 02.07.1999 remain the same.
- 3. In their application to Indian Audit Accounts Department, these orders are being issued after consultation with the Comptroller & Auditor General of India.
- 4. This issues with the concurrence of Ministry of Finance, Department of Expenditure ID Note no. 181/E-V/2017 dated 17.11.2017 and Department of Personnel & Training ID Note no 1265923/17-Estt(Pay-II) dated 18.09.2017.

Notification for continuous empanelment of Health Care Organizations (HCOs) under CGHS, Guwahati

The undersigned is directed to state that MOH and FW has initiated continuous empanelment of **Health Care Organizations** (HCOs) under CGHS cities vide Letter No. S.11045/36/2012-CGHS (HCO), dated 26-12-2017. - 2. A reference has been received whether the OM dated 28.1.2015 and the above mentioned OM dated 8.5.2017 will co-exist. The matter has been examined and it has been decided that the OM dated 8.5.2017 will supercede all the instructions issued on the subject of Model Calendar for Departmental Promotion Committees, including the OM dated 28.1.2015. In other words, the instructions issued *vide* OM dated 8.5.2017 are applicable in all cases, *i.e.*, whether or not it requires DPC to be convened in UPSC or internally within the Departments /

Guidelines on Air Travel on Official Tours – Purchase of air ticket from authorized agent.

The undersigned is directed to refer to this Departments' O.M. No. 19024/22/2017-E.IV dated 19.07.2017 regarding guidelines on Air travel where the Govt. of India bears the cost of passage. As per this O.M., Ministries/Departments were asked to ensure that these instructions are given adequate coverage and were to be circulated to all so that 'lack of knowledge' of the rules is not cited as an excuse. In spite of these instructions, a large number of cases for relaxation of air travel guidelines due to purchase of air ticket from unauthorized travel agents, are still being received in this Department.

2. The matter has been re-considered and it has been decided that all such cases of air travel where tickets have been purchased after issue of this Department's O.M. dated 19.07.2017, seeking relaxation of air travel guidelines pertaining to purchase of air ticket from authorized agent, should have the approval of Secretary of the Administrative Ministry before referring the same to Department of Expenditure.
