विषय: TRAINING AND SUMPTUARY ALLOWANCES TO THE DIRECTOR AND OTHER FACULTY MEMBERS POSTED AT THE ZONAL INSTITUTES OF EDUCATION & TRAINING OF KVS—REGARDING.

In light of the above references, it has been decided by the competent authoritiy on the basis of Government of India orders that the Training Allowances and Sumptuary allowances to the Director and Other Faculty Memmbers posted at the ZIETs of KVS shall be regulated in the following manner:

Sumptuary Allowance in all the Training Establisments / Academies/Institutes stands abolished w.e.f. 1st July, 2017.

2. Training Allowance:

(i)

In the National/Central Training Academies and Institues for Group 'A'	24% of Basic Pay.	Ceiling of 5 years period to be removed.
Officers In other Training Establishments	12% of Basic Pay	Standard cooling off period between tenures will apply.

- (ii) Training Allowance will be admissible only to the employees who join the training establishments for a specified period of time and are then likely to go back.
- (iii) Training Allowance will not be admissible to those employees who are directly recruited by such training establishments for imparting training.
- (iv) The revised rates of training allowance shall be admissible with effect from 1st July, 2017.

The other contents of the letter of even no. dated 14/21-10-2011 remain the same.
