Sir,

I am to invite your attention to the subject cited above and to state that the Dearness Relief @ 125% was granted to the pensioners of Kendriya Vidyalaya Sangathan from 1.1.2016. However the Dearness Relief payable from 1.7.2016, 1.1.2017 and 1.7.2017(1.7.2016 @132%, 1.1.2017 @ 136% and 1.7.2017 @ 139%) are not yet paid to the Kendriya Vidyalaya Sangathan pensioners due to want of specific orders from the Govt. of India, Min. of Finance, Deptt. of Expenditure. The Ministry of HRD, Govt. of India now conveyed the approval for payment of Dearness Relief to the pensioners of Central Autonomous Bodies drawing pre-revised pension as per 6th CPC in terms of the D.O.letter No.1/2/2017-E II(B) dated 26th October, 2017 of Deptt. of Expenditure.

You are now requested to make the payment of Dearness Relief to the Pensioners of Kendriya Vidyalaya Sangathan from 125% to 132% w.e.f. 1.7.2016, 132% to 136% w.e.f. 1.1.2017 and 136% to 139% w.e.f. Additional if funds, any, required for payment Dearness Relief may be informed to this office immediately.

Extension of the orders of DA issued by Department of Expenditure for Central Government employees/ Central Autonomous Bodies employees who are in pre-revised scale of 6th CPC for grant of DR to Pensioners of the Central Autonomous Bodies who are in prerevised pension as per 6th CPC pay.

The undersigned is directed to refer to OM No 1-3/2008-Ell (B) dated 9th November, 2016; 7th April, 2017 and 26th September, 2017 respectively received from Department of Expenditure, Ministry of Finance regarding applicability of Dearness allowance @ 132% as on 01-07-2016, 136% as on 01-01-2017 and 139% as on 01-07-2017 respectively in respect of Central Government employees /Central Autonomous Bodies employees who are in pre-revised scale of 6th CPC.

- To resolve the hardship faced by the pensioners of Central Autonomous Bodies, 2. Department of Expenditure has vide No 1/2/2017-Ell (B) dated 26th October, 2017 advised FAs of the Ministries/Departments to extend the orders of DA issued by Department of Expenditure for Central Government employees/ Central Autonomous Bodies employees who are in pre-revised scale of 6th CPC for grant of DR to Pensioners of the Central Autonomous Bodies who are in pre-revised pension as per 6th CPC under their administrative control.
- Accordingly, Dearness relief of the Pensioners of Central Autonomous Bodies under the administrative control of Ministry of Human Resource Development, Department of School Education & Literacy drawing pre-revised pension as per 6th CPC may be revised from 125% to 132% w.e.f. 01-07-2016, from 132% to 136% w.e.f. 01-01-2017 and from 136% to 139% w.e.f. 01-07-2017.

References have been received in Department of Expenditure seeking clanication on grant of Dearness Relict (DR) to the Pensioners/Family Pensioners of Central Autonomous Bodies who are in receipt of pension in pre-revised pay structure/scales of 6" CPC

- Department of Expenditure issues orders for Dearness Altowence in respect of Central Goyt, employees who are in revised pay scale and also issues orders in respect of Central Gov. employees / Central Autonomous Bodies empirities who are in the pro-religed pay scale. Department of Persion & Pens Theirs Welfare (DoP&PIM) issues orders in respect of Pensioners
- After implementation of 7th CPC, D/o Expenditure issued orders for rates of DA w.e.f. 01.07.2016, 01.01.2017 and 01.07.2017 in respect of Central Govi employees who are in revised pay structure of 7th CPC as well as in respect of Central Govt employees / Central Autonomous Bodies' employees who are in prerevised scale of 6th CPC Department of Pensions & Pensioners Weiters (DoP&PW) issued orders only in to Central Govt. pensioners who are in revised pansion as per 7th CPC. However, it has come to notice that no orders have been issued for DR for pensioners of Central Autonomous Bodies who are in pre-revised pension as per 8th CPC
 - The matter has been considered in this Department. To resolve the hardship being faced by the pensioners of Central Autonomous Bodies, FAa of the Ministries/Departments are advised to extend the officers of DA issued by this Department for Central Govt. employees/Central Autonomious Bodies' employees who are in pre-revised scale of 6th LPC, for grant of DR to pensioners of the Central Autonomous Bodies who are in pre-revised pension as per 5th CPC, under their administrative control.
