## OFFICE MEMORANDUM

Subject: Amendment in Article 40 (a) and 40 (d) of the Education Code.

The Board of Governors in its 109<sup>th</sup> meeting held on 6<sup>th</sup> March, 2018 has amended the provision under Article 40(a) and 40(d) dealing with the payment of Honorarium, Conveyance Charges and TA/DA/Refreshment/Lunch/Dinner etc. to the Members of the Selection Committee and Departmental Promotion Committee.

The amended provisions of Article 40 (a) and 40 (d) will now be read as under:

Honorarium @ Rs.2500/- per day when he/she actually attends the meeting at the place at which he/she has been invited by the Sangathan to be present.</li> <li>b). Conveyance charges @ Rs.1000/- per day or actual expenditure whichever is less.</li> <li>2. Outstation Members:</li> <li>a). Honorarium @ Rs.2500/- per day when he/she actually attends the meeting at the place at which he/she has been invited by the Sangathan to be present.</li> <li>b). T.A. /D.A. as per entitlement as admissible under rules.</li> </ul>
2.	Honorarium and conveyance to the Members of the Selection Committee for recruitment of Officer's Cadre, Teaching and Nonteaching posts.	1. Local Members:  a). Honorarium @ Rs.3000/- per day for Chairman and Rs.2500/- per day for Non-Official Member when he/she actually attends the meeting at the place at which he/she has been invited by the Sangathan to be present.  b). Conveyance charges @ Rs.1000/- per day or actual expenditure whichever is less.

		2. Outstation Members:
		a). Honorarium @ Rs.3000/- per day for Chairman and Rs.2500/ per day for Non-Official Member when he/she actually attends the meeting at the place at which he/she has been invited by the Sangathan to be present.
		b). T.A. /D.A. as per entitlement as admissible under rules.
3.	Expenditure on refreshments/ working lunch	The limit of expenditure for serving refreshments/ working lunch to all the members of the Selection Committee/ Departmental Promotion Committee, which start in the forenoon and continue beyond lunch time including the persons put on duty in connection with recruitment and promotion of staff is Rs.750/- per head per day.

The above amendment shall come into force w.e.f. 23.03.2018.
