Sub: Settlement of Outstanding Internal Audit Paras and AG Audit Paras.

Madam/Sir,

This is in continuation to KVS (HQ) letter No.F.110225/14/2012/KVS(HQ)/Audit dated 16.06.2017 on the subject cited above.

The Finance Committee of KVS in its meeting held on 27th June, 2017 taken serious view on the non compliance of Outstanding Internal Audit Paras of the Vidyalayas and Regional Offices.

During the review of pending Audit Paras it is observed that the Vidyalayas and Regional Offices are not taking effective measures to comply the Audit Paras. Most of the Audit Paras are relating to the procedural lapses. That should have been complied during the Audit itself. It should not have been brought in the Audit Report. Only paras of serious irregularities and paras pertaining to the recovery should be brought in the Audit Report. This should have been taken care at the Regional Office level before issuing the Internal Audit Report and requisite follow up should be continuously reported to KVS (HQ) every month as sought vide this office letter of even number dated 6.12.2016, 24.3.2017 & 30.5.2017 in prescribed format.

The following Action Plan is drafted for immediate compliance of the outstanding Internal Audit Paras/AG Audit Paras:-

- (1) All the Regional Offices should conduct the Audit Adalat for the compliance of the Internal and AG Audit reports in three spells.
- (2) First Audit Adalat should be organized in the month of July 2017 for the Internal Audit Paras.
- (3) Second Audit Adalat should be organized in the month of August 2017 for the pending Internal Audit Paras and for the AG Audit Paras.
- (4) Third Audit Adalat should be organized in the month of September 2017 for the pending Internal Audit Paras and for the AG Audit Paras.

(5) The return in the following format may be forwarded to the KVS (HQ) every month to monitor the progress of compliance Audit Paras:-
