The Kendriya Vidyalaya Sangathan will be conducting Limited Departmental Examination for filling up the posts of Principal from amongst eligible Vice Principals of KVS.

2. The Feeder Posts and Eligibility Criteria for the post of Principal to be filled by LDE shall be as per KVS Recruitment Rules in vogue (i.e. as amended and effective from 12-02-2014) as under:

"The candidate should have 08 Years combined regular services as PGT in the Pay Band of Rs.9300-34800/- with Grade Pay Rs.4800/- and Vice-Principal in the Pay Band of Rs. 15600-39100/- with Grade Pay Rs.5400/- out of which 02 Years as Vice-Principal"

The interested and eligible Vice-Principals fulfilling the terms & condition as mentioned in this notification and as per KVS Recruitment Rules will have to apply OFF-LINE by filling details in the Application Form in his/her own hand writing in CAPITAL LETTERs using BLUE BALLPEN through proper channel i.e. through Principal/ Deputy Commissioner (where Incharge Principal/ Principal Gd.ll is applying himself/ herself for the post) and further counterchecked by the Dy. Commissioner concerned by submission of HARDCOPY complete in all respects i.e. Self undertaking from the employee and certificate from the Competent Authority. Principal/ Deputy Commissioner concerned will attest the photograph of the employee with their seal and the employee has to sign in the box below the photograph pasted.

- 5. The Principal/ Deputy Commissioner will verify the eligibility as well as details filled by the candidate from his/ her service record and certify the same under his signature before transmitting the Original Application (s) to the Dy. Commissioner of the concerned Regional Office.
- 6. On receipt of the applications the Dy. Commissioner of the concerned Region will check and countersign each Application and prepare a consolidated detail of each applicant in the enclosed EXCEL FORMAT (Annexure-A) and forward the same with scanned Applications through e-Mail to rps313kvshq@gmail.com followed by hard copies by SPEED POST to Jt. Commissioner (Admn.), KVS(HQ) in a single bunch with title "Application for LDE for the post of PRINCIPAL".
- 7. The details of the ineligible Vice-Principals, if any, received from the Principals of KVs will be recorded on the face of the covering letter with specific comments of the Deputy Commissioner concerned. Total number of applications Category wise shall be mentioned by the Dy. Commissioner while forwarding Applications to KVS (Hqrs.).
- 8. While forwarding the Application in original, it may be ensured by the Deputy Commissioner concerned that the particulars/ Bio-data of the applicant is as per the office records, and duly certified by the Principal concerned as no change in Original Application will be permitted at any stage, once it is submitted by the Principal concerned.
- 9. Merely submission of application will not confer any right upon a candidate to appear in the written examination. The candidature of the applicant shall be cancelled at any stage, even after conduct of examination and issue of Posting Order, if found, that the particulars filled by the candidate are incorrect or he/she is not eligible for the post of PRINCIPAL as per Recruitment Rules of KVS for the post of Principal.
- 10. The Limited Departmental Examination for the post of Principal is likely to be conducted in the month of September, 2017 in DELHI only. Exact Date of Limited Departmental Examination will be communicated shortly on receipt from the CBSE i.e. the Recruitment Agency.
