Madam/Sir,

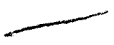
I am to invite your attention to the subject cited above and to say that KVS in its 101st meeting held on 13.03.2015 approved the project of implementation of MIS/ERP in all its Kendriya Vidyalaya through NICS I empanelled vendor M/s MGRM Net Ltd. The said decision was based on the recommendation of Finance Committee of Kendriya Vidyalaya Sangathan to the Board of Governors (BOG) for implementation of MIS/ERP in KVS through NICS I empanelled Vendor.
