Sub: - Revision of Pre-2006 pension cases of KVS Pensioner's reg:-

Sir/Madam,

The issue of revision of Pre-2006 pension cases is seeking attention of Kendriya Vidyalaya Sangathan (HQ) for quite some time. In this regard, one of the Pensioners' Associations met the Commissioner, KVS on 22.02.2017. The Commissioner, KVS directed that all the Pre-2006 Pension cases should be revised within 30 days by KVS(HQ) as well as Regional offices.

- 2) In this connection, your attention is also invited to the following Office Memorandums issued by Government of India, Department of Pension & Pensioners' Welfare on the subject:
- I) OM No. 38/37/08-P&PW(A) dated 01.09.2008 regarding revision of Pre-2006 pensioners alongwith the table stating Revised Basic Pension without Dearness Relief.
- II) OM No. 38/37/08-P&PW(A) dated 28.01.2013 vide which minimum pension in reference to the sum of minimum of pay in the pay band and the grade pay corresponding to the pre-revised pay scale from which the pensioner had retired was fixed Effective from 24.09.2012.
- III) OM No. 38/37/08-P&PW(A) dated 30.07.2015 vide which the applicability of OM dated 28.01.2013 made effective from 01.01.2006.
- IV) OM No. 38/37/08-P&PW(A) dated 06.04.2016 regarding delinking of revised pre- 2006 pension from qualifying service of 33 years.

It may be recalled that the aforesaid Office Memorandums were circulated to all the Regional Offices/ZIETs by KVS(HQ) from time to time for compliance. In the mean while, KVS(HQ) also sought clarification from the Ministry of Human Resource Development about the Grade Pay applicable to the Pre-2006 pensioners for revision of pension consequent upon the revision of Pay Scales as per VIth CPC and the Ministry of Human Resource Development clarified vide its letter No. 3-14/2012-UT-2 dated 08.12.2016 (copy enclosed) as under:

"in respect of the Principals of KVS who retired before 01.01.2006, their pension and family pension would have to be fixed with respect to the amounts indicated in Column 9 and 10 of the Annexure to D/o P&PW OM dated 28.01.2013 corresponding to the scale of pay applicable prior to 01.01.2006 i.e. Rs. 12600/- and Rs.7560/- respectively. Same criteria would hold good in respect of other category of employees also."

3) You are directed to revise all the Pre-2006 Pension cases in a war footing manner and the compliance to the said exercise may be furnished to Kendriya Vidyalaya Sangathan (HQ) in the following specified format latest by 30th March 2017.
