MEMORANDUM

SUBJECT: Filling up the Posts of Stenographer Grade I by promotion for the year 2015-16. (Main Panel: Unreserved Category)

The Competent Authority has approved promotion of the following Stenographer Grade II to the post of Stenographer Grade I in the pay band/ Scale of Rs.9300-34800/- with Grade Pay of Rs. 4200/- and posted to KVS ROs/ZIET as shown in column 6 against their name. They must communicate their unconditional acceptance positively by 28.04.2016 and get relieved for joining the place of posting as Stenographer Grade I after availing joining time as per rules. If they fail to get relieved by 28.04.2016 this offer of promotion will automatically be treated as withdrawn and they would be debarred from getting further promotion for 01 year with attendant consequence such as seniority etc. with effect from 29.04.2016 as per KVS (HQrs.). letter No.6-6/1999/KVS(HQ)RPS dated 4.9.08.

- 2. The promotion made under SC/ST quota is subject to production of recent certificate obtained from the competent authority of State Govt. in support of his continuing to belong to SC/ST as the case may be.
- 3. The employee will have the option to get his pay fixed from the date of promotion or from the date of increment in the lower post, i.e., on 1st July. The option should be exercised within a month of promotion.
- 4. No extension of joining time shall be allowed except for reasons of illness/confinement of the employee duly supported by medical certificate from Chief Medical Officer / Medical Supdt. / Civil Surgeon of Govt. Hospital / Distt. Hospitals or from Chief Medical Officer of the Hospital of Public Sector Undertakings/Projects to which the school is attached/Military or Command Hospital as a case may be. The request, if any, for extension should be submitted through proper channel by 28.04.2016 to KVS(HQ) positively.

5. It is also made clear that representation for either change of place of posting on promotion or for extension of time to join the post (other than covered under para 4 above will not be entertained under any circumstances.
