Madam/Sir,

It is a matter of appreciation that fee of Rs 195.32 Crores has been collected in the fourth phase from almost 10.30 lakh students. Fee is fully exempted from approximately 1.14 lakh students and thus target of quarterly collection stand achieved to the tune of 96%.

It has already been announced in the DCs Conference that 100% automation target is to be achieved from 1<sup>st</sup> October, 2015. Following remaining components/areas are to be automated to achieve target of 100% automation by 31<sup>st</sup> December, 2015.

- 1. Fee to be collected at the time of admission
- 2. Re admission
- 3. Arrears of previous quarter
- 4. Advance fee
- 5. Issuance of Transfer Certificate.

In order to familiarize officials of all KVs, a brief orientation program has been scheduled in third and fourth week of August, 2015 as per schedule annexed to discuss procedural aspects of the areas to be automated and other miscellaneous aspects to achieve 100% automation. The session will be completely interactive.

Two officials (per shift) from all the KVs (one principal/Vice principal, one teacher who is in-charge of fee collection program) may please be deputed to attend program. Also the Nodal Officer, Finance officer and two official dealing with fee collection in Regional office may also be nominated to attend the orientation program.

The venue of training should have capacity to accommodate official invited at that place in **one slot (approximately four hours)** and facility of projector along with internet connectivity. The venue to be decided and communicated by the respective Regional office to all officials of the Region to whom training is to be imparted. The date and timing of orientation program is annexed herewith for your reference.
