The In Service Courses for various cadres of teachers are about to begin shortly in all the regions. It is felt that the element of Yoga should be included in the 12-day ISC in order to enhance their health and wellness and bring out the vitality among teachers and students.

Isha Foundation is offering scientifically structured Yoga based programmes for this purpose and it has been decided to allot a slot to them in the In-Service Courses of PGTs/TGTs venues for the benefit of the participants. The following may be noted in this regard.
