MEMORANDUM

SUBJECT: Offer of appointment to the post of Principal.

With reference to his application for the post of Principal, SH. MUKESH KUMAR VERMA, is hereby informed that he has been selected for appointment against a temporary post of Principal in the Kendriya Vidyalaya in the Pay Band of Rs. 15800-39100 (PB-3) + Rs.7600 as Grade Pay and posted in Kendriya Vidyalaya, KARIMGANJ. He will draw allowances and other benefits in addition to pay at the rates as admissible to Kendriya Vidyalaya Sangathan employees. This offer of appointment is subject to the candidate being declared fit for the post of Principal by a Civil Surgeon.

- No TA will be admissible for the first joining of the Sangathan as Principal.
- 3. He will be on probation for a period of two years from the date of appointment, which may be extended by another one year by the competent authority for the reasons to be recorded in writing. Upon successful completion of probation, he will be confirmed in his turn as per KVS Rules.
- 4. During the probation and thereafter, until he is confirmed, his services are terminable by one month's notice on either side without any reason being assigned therefore. The appointing authority, however, reserves the right to terminate the services of the appointee from the post of Principal before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay & allowances for the period of notice of the unexpired portion thereof.
- 5. He will be liable to be transferred anywhere in India.
- 6. He will be governed by Kendriya Vidyalaya Sangathan Employees Welfare Scheme.
- 7. He will be eligible for New Restructured Defined Contributory Pension Scheme only as circulated by KVS (HQ) vide circular No. F.2-17/2003-04/KVS(Budget) dated 08/12.03.2004 and F.2-17/2003-04/KVS (Budget) dated 24.12.2004.
- 8. The appointment to the post of Principal is provisional and is subject to the condition that the Scheduled Caste/Tribe Certificate/OBC/Physically Handicapped certificate being verified through proper channel. If the verification reveals that the claim to belong to SC/ST/OBC/PH as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates. In case of Other Backward Classes if the verification reveals that the claim of the candidates not to belong to creamy layer is false his services will be terminated forthwith without assigning any further reasons.
- 9. In case of any dispute or claim against KVS, in respect of service of any contract arising out to or following from this offer of appointment, the court at Delhi alone shall have the jurisdiction.
- 10. If he accepts the offer of the terms & conditions stipulated he should send his acceptance in prescribed proforma enclosed herewith latest by **21.09.2015** to this office on receipt of this memorandum and will join the Kendriya Vidyalaya mentioned above on or before **13.10.2015**. If the offer is not accepted by the said date or after acceptance if the appointee does not report for duty at his place of posting by **13.10.2015**, this offer of appointment will automatically stand cancelled and no further correspondence will be entertained from him.

- 11. Suppression of any information will be considered a major offence for which the punishment may extend to dismissal from the service.
- 12. He/she will not request for transfer within one year of initial appointment on the first posting. He/she is liable to be transferred anywhere in India.
