Dear Madam/Sir,

I am to refer to the subject cited above and to enclose a list of candidates who have been empanelled in the Main Panel for appointment to the post of **Assistant** for the years 2012-13 & 2013-14. It has been decided to post them in your region. Proforma of Offer of appointment is enclosed.

The place of posting will be decided by your office as per availability of vacancies in various Kendriya Vidyalayas under your jurisdiction according to the following criteria:-

- (a) Blind / Physically Handicapped to be given their choices near to their home town subject to availability of vacancies.
- (b) Female candidates should be posted as per their choice / to their Home State pertaining to their Home District (subject to availability of vacancies) / in the project KVs as per their merit position in the list i.e. the process of allotment of Kendriya Vidyalayas should be started from the top most female candidate to the listed at the bottom.
- (c) First priority should be given to post candidates in the Kendriya Vidyalaya Sangathan RO/ KVs located in project sector / IHL sector where vacancies are available and also in Kendriya Vidyalaya where there is acute shortage of staff.
- 2. The offer of appointment may be issued by speed post / registered post immediately. While issuing the individual appointment order to the candidate, they may be given time of THIRTY (30) DAYS to join his/her duties in the allotted Kendriya Vidyalaya Sangathan RO/Kendriya Vidyalaya.
- 3. A consolidated list of candidates who have been issued offer of appointment in the above manner should be displayed in Regional website immediately.
- 4. Character antecedents verification form duly filled by the candidate along with recent photograph will be collected by the Principal of the KV who will send the same to the concerned authority/ DM of the District to which the candidate belongs to immediately to get it verified. It may be ensured that the verification report is received at the earliest.

- The application form (in original) with its enclosures in respect of the candidate is also enclosed. The claims of candidate belonging to SC/ST/OBC/PH/BL have been provisionally accepted on the basis of certificate produced by them at the time of interview. The individual candidate may be directed to produce all original certificate and documents in proof of their qualification and their belonging to SC/ST/OBC/PH etc., issued by the competent authority to the Principal at the time of reporting for joining duty. The Principal should permit the candidate to join only if the candidate produces all original documents and also photocopies of these documents. The Principal should also ensure that they fulfill the prescribed qualifications, age, etc. as advertised and required for appointment to the post of Assistant also as filled in his/ her application form. In the case of SC/ST/OBC candidates, provision exists for issue of provisional offer of appointment pending verification of the veracity of those documents. In this connection instructions as contained in Department of Personnel & Training OM No. 36012/6/88-Estt(SCT) SRD(III) dated 24.4.90 may kindly be referred to and complied with. In the case of OBCs compliance of the instructions as already issued by Department of Personnel and Training, Govt. of India from time to time since the issue of OM No. 36012/22/93-Estt(SCT) dated 8.9.93 may also kindly be ensured (copy enclosed).
- 6. No candidate should be allowed extension in joining date except in deserving cases. In case the candidate does not report for duty by the stipulated date the offer of appointment will be treated as withdrawn except in the case of lady candidates who are in family way or on genuine medical grounds for both female and male candidates. No request for change of place of posting may be entertained.
- 7. As regards Medical Examination of the newly recruited Candidates the instructions contained in KVS letter No.F.11038/PGT/Main/2014/KVS(HQ)/Estt.-II dated 17/9/2014 may be adhered to.
- 8. It may be ensured that the transfer of the **Assistant** should not be resorted to on the pretext of adjusting the new appointee.
