However, if the same is not available, the records/Ranking up to the 3rd place may be obtained from the Regions concerned (Host region of 43rd KVS National Sports Meet-2012) before selection of participants for 44th KVS National Sports Meet-2013.

The Deputy Commissioners of Regional Office, Lucknow and Mumbai are also requested to cooperate and provide a copy of the KVS records/Ranking in related sports/events of 43rd KVS National **Sports Meet-2012** to all other regions for ready reference.
