MEMORANDUM

- (2) The promotion made under SC/ST quota is subject to production of recent certificate obtained from competent authority of State Govt. in support of his continuing to belong to SC/ST as the case may be.
- (3) The employee will have the option to get his pay fixed from the date of promotion or from the date of increment in the lower post, i.e., on 1st July. The option should be exercised within a month of promotion.
- (4)No extension of joining time shall be allowed except for reasons of illness/ confinement of the employee duly supported by medical certificate from Chief Medical Officer / Medical Supdt. / Civil Surgeon of Govt. Hospital / Distt. Hospitals or from Chief Medical Officer of the Hospital of Public Sector Undertakings/Projects to which the school is attached/Military or Command hospital as a case may be. The request, if any, for extension should be submitted through proper channel by 5.11.2015 to KVS (HQ) positively.
- (5)It is also made clear that representation for either change of place of posting on promotion or for extension of time to join the post (other than covered under para 4 above will not be entertained under any circumstances.

- 1. The individual concerned to communicate his acceptance positively by 5.11.2015. In case of acceptance of promotion, he/she is directed to get relieved on or before 5.11.2015 failing which he/she is deemed to have been relieved on 5.11.2015.

If the official is willing to proceed on promotion, he/she must convey his/her unconditional willingness/consent to the Kendriya Vidyalaya Sangathan (HQ) through the Principal by 5.11.2015.
