The United States-India Educational Foundation (USIEF) has informed vide letter dated 16.02.2017 as under:-

United States-India Educational Foundation (USIEF) has announced the 2017 Teaching Excellence and Achievement Program (TEA) for full time school teachers (grades 6 to 12) teaching **English, Social Studies, Mathematics, Science and Special Education** at schools in the states of **Chandigarh, Delhi, Haryana, Himachal Pradesh, Jammu and Kashmir, Punjab, Rajasthan, Uttarakhand, Uttar Pradesh, Chhattisgarh, Goa, Gujrat, Madhya Pradesh, Maharashtra, Daman and Diu and Dadra and Nagar Haveli**. This competition is open only to teachers from the states mentioned above and not the rest of India. The U.S. Government sponsored program provides international teachers with unique opportunities to develop expertise in their subject areas, enhance their teaching skills and increase their knowledge about the United States.

The U.S. based academic program will include semester-long non-degree, non-credit academic program at a University including seminars on new teaching methodologies, curriculum development, lesson planning and teaching strategies. Selected Indian teachers will receive round-trip transportation, room and board and applicable allowance and will travel on J-1 visas.

Details regarding the Program and the application form/procedure have been uploaded on **USIEF website i.e, (www.usief.org.in)**. Candidates can access the online application at <http://oas.irex.org/tea> for submit the online application along with supporting documents.

The last date of submission of online application is 03.04.2017.

You are requested to bring it to the notice of the teachers teaching in above mentioned subjects in Kendriya Vidyalayas under your jurisdiction. The hard copy of the application should reach this office by 15.03.2017 for proceeding and further forwarding by this office.
