He will have an option to get his (i) pay fixed from the date of promotion OR (ii) pay fixed from the date of accrual of next increment in the scale of pay of lower grade held by him. The option shall be exercised by him within one month from the date of joining on promotion and option once exercised will be final.
 - If he does not submit the acceptance by the stipulated date, it would be presumed that he has declined/refused the offer of promotion. Refusal of promotion would entail no fresh offer of promotion being made to him for a period of ONE YEAR from the date of refusal. Further, in case of refusal he, on eventual promotion to the above post, will lose seniority vis-a vis erstwhile junior promoted to the above post earlier.
