MEMORANDUM

SUBJECT: Offer of appointment to the post of Technical Officer.

With reference to his application for the post of Technical Officer, Sh. AMIT AWASTHI, is hereby informed that he has been selected for appointment against a temporary post of Technical Officer in the Kendriya Vidyalaya Sangathan in the Pay Band of ₹ 9300-34800 (PB-2) + ₹ 4600 as Grade Pay and posted at Kendriya Vidyalaya Sangathan, Headquarters, New Delhi. He will draw allowances and other benefits in addition to pay at the rates as admissible to Kendriya Vidyalaya Sangathan employees. This offer of appointment is subject to the candidate being declared medically fit for the post of Technical Officer by a Civil Surgeon/ CMO of Govt. Hospital.

- 2. No TA will be admissible for his first joining to Kendriya Vidyalaya Sangathan.
- 3. He will be on probation for a period of two years from the date of appointment, which may be extended by another one year by the competent authority for the reasons to be recorded in writing. Upon successful completion of probation, he will be confirmed in his/her turn as per KVS rules.
- 4. During probation and thereafter, until he is confirmed, his services are terminable by one month's notice on either side without any reason being assigned therefore. The appointing authority, however, reserves the right to terminate the services of the appointee from the post of Technical Officer before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay & allowances for the period of notice or the unexpired portion thereof.
- 5. He will be governed by Kendriya Vidyalaya Sangathan Employees Welfare Scheme.
- 6. He will be eligible for New Restructured Defined Contributory Pension Scheme only as circulated by KVS (HQ) vide circular No. F. 2-17/2003-04/KVS(Budget) dated 08/12.03.2004 and F.2-17/2003-04/KVS(Budget) dated 24.12.2004.
- 7. Suppression of any information will be considered a major offense for which the punishment may extend to dismissal from the service.
- 8. The appointment to the post of Technical Officer is provisional and is subject to the condition that the Scheduled Caste/Tribe Certificate/OBC/Physically Handicapped certificate being verified through proper channel. If the verification reveals that the claim to belong to SC/ST/OBC/PH as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates. In case of Other Backward Classes if the verification reveals that the claim of the candidate not belong to creamy layer is false his services will be terminated forthwith without assigning any further reasons.
- 9. In case of any dispute or claim against KVS, in respect of service or any contract arising out to or following from this offer of appointment, the court at Delhi alone shall have the jurisdiction.

- 10. If he accepts the offer of the terms & conditions stipulated he should send his acceptance latest by 30.03.2015 to this office on receipt of this memorandum and will join the Kendriya Vidyalaya Sangathan mentioned above on or before 21.04.2015. If the offer is not accepted by the said date or after acceptance if the appointee does not report for duty at his place of posting by 21.04.2015, this offer of appointment will automatically stand cancelled and no further correspondence will be entertained from him.
- 11. He will fill up the character antecedents verification form alongwith recent photographs at the time of joining.
