Sub: Temporary admissions of bona-fide KV-students of Kendriya Vidyalayas in Kashmir Valley displaced due to floods - regarding .

Madam/Sir,

KVS has received requests from parents of KV-students who have been displaced due to unprecedented floods in Kashmir Valley for admissions of their wards in other Kendriya Vidyalayas. A detailed report and proposals were also received from Deputy Commissioner, KVS(RO), Jammu vide letter No.240350/2013-14/KVS(JR) dated 15.9.2014 & 17.09.2014 in this regard.

The competent authority of KVS has taken a sympathetic view on this issue and accordingly following instructions are to be followed in this regard:-

- The parents of the bona-fide KV-students of Kendriya Vidyalayas of Kashmir Valley displaced due to floods may approach nearest Kendriya Vidyalayas OR Regional Office of KVS for provisional admission of their wards.
- 2. The parents may apply for provisional admissions of their wards in a prescribed format (Annexure-1) with recent photograph of the student giving all details. An undertaking (see Annexure-1A) from the parents is also to be submitted along with the admission form to the Principal for seeking temporary admission.
- The Principal after obtaining the application form and undertaking may allow the student concerned to attend the classes and in the mean-time send the documents to Deputy Commissioner of the Region concerned for approval.
- The Deputy Commissioner of the Region concerned may allow the provisional admission for a period of two months initially till the parent is able to obtain transfer certificate and other documents from the KV in Kashmir Valley.
- 5. To facilitate the parents seeking temporary admission, the Principal of the KV concerned will scan the application form of the displaced- KV-students and send it across to the Principal concerned in Kashmir Valley/other places for verification immediately. All possible help may be extended to such KV- students on humanitarian grounds.
- 6. The Principal of the Kendriya Vidyalayas in Kashmir Valley are to attend such cases of verification requests or requests of parents for issuing Transfer Certificate(TC) on priority basis so that the temporary admission granted in other Kendriya Vidyalayas can be regularized at the earliest (within two months).
- 7. The parents may be advised to apply for Transfer Certificate (TC) from the Kendriya Vidyalaya in Kashmir Valley in prescribed format and the same may be sent to concerned Kendriya Vidyalaya by post and/or else scanned copy may be forwarded officially to obtain the TC. However, it is the responsibility of the parents to make efforts for obtaining TC at the earliest (within two months).

All concerned are requested to note that these temporary admissions of bona-fide KV-students displaced from Kendriya Vidyalayas in Kashmir Valley are subject to verification of facts and records. KVS/KV has the liberty to cancel the admission if any misrepresentation of facts and/or false information given by the parents comes to or is brought to the notice of KVS/KV authorities. This may also be followed by proceedings against such parents as per provision of law in this regard.
