Consequent upon establishment of 07 new Regional Offices with staff of 20 in each Regional Office which is less than staff sanction in each of the earlier existing Regional Office of KVS, it is incumbent upon KVS to rationalize the sanction of these posts in all Regional Offices to make them more equitable. Hence the competent authority has decided to re-distribute the number of posts in respect of Group-B & C non teaching posts (below the post of Section Officer) for each Regional Office with immediate effect as indicated hereunder:
