

## TERMS AND CONDITIONS

- (i) The earnest money of Rs 20000/- (Rupees twenty thousand only) shall be deposited alongwith tender form available in Room No 213 of KVS(HQ) at the cost of Rs 200/- (Rupees two hundred only) on all working days from the date of advertisement till start of bid i.e 10.30 of 22.10.2011 on the submission of written request on the letter head of the firm showing the Sales Tax Registration No of the firm etc. The demand draft may be deposited in favour of KVS(HQ), New Delhi along with tender form. The bid will not be entertained until and unless the same is received in the tender form.
- (ii) The bid of the highest bidder for goods on "as is where is basis" will be accepted on the basis of total bid amount of all condemned items.
- (iii) Full payment after adjusting the bid earned money shall be collected/obtained from the successful bidder before releasing the goods.
- (iv) The reserve price of condemned articles is Rs 200000/- (Rupees two lacs only)
- (v) The bid security of the successful bidder will be retained. The Bid security of unsuccessful bidders will be returned within 15 days of finalization of bid.
